Job specification

This role is ideal for a qualified professional who wants to make a meaningful impact in the voluntary sector. You'll oversee the compliance of our building services—mechanical, electrical, and public health—ensuring our spaces are safe, accessible, and legally compliant.

Key Responsibilities

- Ensure all building services comply with current UK Building Regulations (Parts A–P) and statutory requirements.
- Conduct periodic compliance checks and advise on remedial actions.
- Maintain accurate records of inspections, certifications, and maintenance schedules.

- Liaise with contractors, inspectors, and local authorities to support approvals and upgrades.
- Advise trustees and staff on regulatory changes and their implications.
- Support our commitment to sustainability and accessibility, including compliance with Part L (energy) and Part M (access).
- Support the caretaker, manage their weekly task list and liaise as required.

General requirements

- You will be directly responsible to the board of trustees.
- All employees will be expected to be flexible in their hours and duties and carry out any other duties as requested
- Duties and responsibilities must be carried out in accordance with the charity's policies and procedures, within legislation and any code of professional ethics of relevant professional body
- To demonstrate and positively reinforce our commitment to safeguarding and promoting the welfare of children and adults at risk
